1. What is a National Young Woman of Distinction (NYWOD)?

National Young Woman of Distinction is the designation, and special honor, conferred by Girl Scouts of the USA (GSUSA) on ten Girl Scout Gold Award recipients whose final projects demonstrated extraordinary leadership, had a measurable and sustainable impact, and addressed a local challenge that related to a national and/or global issue.

2. Who is eligible to apply for this honor?

Any Girl Scouts of Greater Los Angeles (GSGLA)Girl Scout who completed her Girl Scout Gold Award from March 1, 2014, to April 1, 2015.

3. How do I apply?

The application can be found on the following page and on our website. Be sure to include all of the requested documents when you submit the completed application.

4. What is the application deadline?

All submissions wishing to be considered must be received at NYWOD@girlscoutsla.org by 11:59pm on May 1, 2015.

5. Where do I submit my application?

Applications MUST be submitted by email directly to:

6. What do I title my application file when I submit it?

We would like all submissions to be submitted by email as an attachment using a Word document. Please title your attachment in the following way: First Initial.Last Name. NYWOD2015.doc EXAMPLE: **G.Scout.NYWOD2015.doc**

7. What happens after I submit my application?

GSGLA has a committee that reviews the applications received by the deadline, and selects up to **three** nominees. The council will work with the selected three girls to prepare their submissions as GSGLA nominations to GSUSA. During the selection process at GSUSA, a panel of corporate and community leaders will assist in choosing the ten NYWOD from the pool of national nominees.

8. When will the council's (GSGLA) nominees be chosen?

GSGLA will review submissions and select the *top three* applicants as our nominees for the NYWOD. These nominees will be forwarded to GSUSA May15th. The council will notify all applicants of their status at that time. Please note: If you are chosen as one of the three GSGLA nominees, you will be asked to create/submit a one-minute video about your Gold Award project and complete an additional online registration form.

9. How will the National Young Women of Distinction be recognized?

Each National Young Woman of Distinction will receive:

- A \$5,000 academic scholarship made possible by the Kappa Delta Foundation
- A \$10,000 Distinction scholarship award from GSUSA
- Training in public speaking
- Recognition at an award ceremony held on October 7, 2015, in New York City or other destination(s) as indicated by GSUSA

- The opportunity to present a TED-talk-style live-stream presentation about her Gold Award project to a national audience during International Day of the Girl on October 8, 2015, in New York City
- The opportunity to be featured in a video that will be streamable on GSUSA's website, YouTube, and Facebook. A profile featured on GSUSA's Facebook page, blog, and other social media outlets
